## TOURNAMENT RULES

Read carefully and be certain all bowlers you enter understand the rules. This responsibility is assumed by the person who completes the entry form. Please fill in all requested information on reverse side.

**A one lane courtesy on either side is to be observed - your cooperation is appreciated.**

1. Bowler must be a member of the MO Capital Area USBC to participate. USBC Rules and regulations will govern the tournament. Non association USBC members must pay local dues of \$9.00 local dues. Non USBC members must pay \$25 USBC dues.
2. All teams will be in one division to determine the team championship. Doubles, Singles and All Events will be one division.
3. Makeup teams permitted. Members of mixed leagues, extra members of teams, and unattached substitutes eligible.
4. All USBC averages must be established in a sanctioned league and will be used in the following order:
  - A. Highest sanctioned league average of 21 games or more at the end of the 2022-2023 season.
  - B. If none of the above, the entrant's highest league average of 21 games or more as of tournament participation date. **(Bowlers must obtain written verification from the league secretary to turn in at check-in time.)**
  - C. All others will bowl scratch.
  - D. 10 Pin rule will not apply.
5. Bowlers may enter as often as they wish in team event, and up to three times in Singles and Doubles. A bowler entering more than once in team event must count first participation toward All Events. No more than 3 players on one team can compete together once in the team event. Bowlers bowling Doubles multiple times must have a different partner each squad.
6. All Events will be handicap or scratch and available by payment of an optional fee of \$5.00. An All Events entry may be transferred, provided the transfer is made before the bowlers involved have participated in any events of the tournament.
7. Handicap will be 80% of the difference between the average and 220.
8. Substitutes must take the place in the lineup of the original entrant.
9. Three sets of doubles will be scheduled to a pair of lanes. When this is not possible, no less than two complete sets will be scheduled to a pair.
10. **Team captains must check in entire team 30 minutes prior to scheduled bowling time**, at which time, substitutions may be made. Bowlers in Doubles and Singles must also check in 30 minutes prior to bowling time.
11. There will be 10 minutes of practice before the start of the Team Event and 10 minutes of practice before the start of Doubles Event. Doubles will be bowled first with no practice for Singles Event. Doubles and Singles will be bowled on the same pair of lanes.
12. Any bowler arriving after the game has started will be allowed to bowl and the games to count beginning in the frame being bowled. **NO SCORE WILL BE GIVEN FOR FRAMES MISSED.**
13. Prize money to be distributed to the winners within 30 days after the tournament is over. Prize money will be distributed one place for each 5 entries.
14. **THE BOARD OF DIRECTORS OF THE MO CAPITAL AREA USBC SHALL DECIDE ANY QUESTIONS NOT COVERED BY THESE TOURNAMENT RULES.**
15. The entrants whose names appear herein or their authorized replacements hereby agree that the MO Capital Area USBC., its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through premature termination which may be brought about by war, national emergency or emergencies or causes relating hereto or resulting therefrom, fire, strikes, lockouts, labor difficulties or other causes beyond the control of the MO Capital Area USBC.
16. Bowlers are asked to wear suitable attire when participating in this tournament. Short shorts, halter tops or tube tops are not considered suitable attire.
17. Any entrant who is loud, vulgar or obnoxious, who willfully delays the normal process of the game or whose conduct on the lanes is considered objectionable may be removed from the lanes at the discretion of the tournament director, whether a qualified substitute is available or not.
